Regular Monthly Public BOD Meeting  
July 10, 2023**

David Levy called the Regular Monthly Public Meeting to order at 2:00 p.m., on July 10, 2023.

**Directors Present:** David Levy, Tammy Becht, Kristen Sanders, Christopher Parker.  
A quorum is present.

**Directors Absent:** Judith Schmidt had an excused absence.

**Firefighters/Volunteers Present:** Chief Mark Norris

**Public Present:** Peter Sanders

**Purpose of Regular Monthly Public Meeting:** To discuss agenda items for the regular monthly Board of Directors Meeting.

**CALL TO ORDER AND ROLL CALL** – Quorum established (at least 3 Directors Present)

**PUBLIC INPUT**

No members of the public were present to offer input at the meeting.

**SECRETARY'S REPORT**

Tammy asked to make a correction from the June 12, 2023, meeting minutes. The District received APX6000 mobile radios not "ABX".

**Motion:** It was moved by David Levy and seconded by Kristen Sanders to approve the Regular Board Meeting Minutes of June 12, 2023 with the correction of the radio name change above. There were no responses to the request for discussion. The Motion was voted upon and carried unanimously.

**TREASURER'S REPORT**

**Chris pointed out certain items on the lead sheet to the Treasurer's Report:**

1. The District increased its cash position before reserves this month to \$168,148. The QB checking account cash balance, before reserves, as of April 30, 2023, was \$167,532. Chris mentioned that the District received an additional \$24k in tax revenue.
2. The second budget amendment of 2023 was roughed out and circulated on June 28<sup>th</sup>. Tammy will put a notice in the paper for a Public Hearing to discuss the 2<sup>nd</sup> amendment to the budget at the next BOD meeting August 14, 2023.
3. AJE's were made to correct A/P as discussed last month.
4. Still need to consider committed funds. A discussion occurred about moving QB category 3132.11 to 3132.12 into unassigned funds.
5. There was discussion about increasing the emergency fund to \$100k. The major income reserves of 35k will be increased to 50k. There is already 50k in the money market in The Bank of San Juans now. These 2 accounts will total the \$100k for the emergency fund. When more income is deposited from the current deployments, the additional 15k will be transferred to Bank of San Juan for that purpose.

**Motion:** It was moved by David Levy and seconded by Kristen Sanders to approve the proposed 2<sup>nd</sup> Budget Revision to be presented at the next Public Hearing meeting August 14, 2023. There were no responses to the request for discussion. The Motion was voted upon and carried unanimously.

**Motion:** It was moved by David Levy and seconded by Tamara Becht to approve the Treasurer's Report for June's Financial Statements, 2023. There were no responses to the request for discussion. The Motion was voted upon and carried unanimously.

## **OPERATIONS REPORT**

Chief Norris discussed the highlights of the June Operations Report:

- Incidents: - 12 Incidents in June, 52 total incidents for 2023 (136 - 2022, 147 - 2021, 146 - 2020)  
- See accompanying response reports.
- Avg Arrival Times: 16:20 minutes:seconds For June / 13:58 minutes:seconds YTD average
- 2023 Membership: - 12() Active Members, 3() Probationary, 1() Recruit, 6() Engine, 6(+1) Overhead, 6() Auxiliary Members
- Updates & Project Status: Stop the Bleed for the community is being scheduled based on instructor availability.
- Water tanks at the Canyon Springs station are mostly buried. Weather and Fire Restrictions stopped progress. Final connections need to be installed and burial completed.
- There are currently 2 deployments: 1 in Colorado and 1 to Nevada then on to California.

Chief Norris stated that there is still an engine in need of repair and the approximate quote to fix will cost around \$17k which is less expensive than purchasing a new vehicle.

It was mentioned that the reporter for the Daily Record wrote a nice article for the TFPD regarding the need for volunteers for both firefighters and Board Members. Chief Norris discussed that there are several volunteers interested in the firefighter positions. He stated there have been zero gaps in coverage even with the loss of our recent firefighters. Volunteer firefighters must be at least 18 years of age. And for Board Members, volunteers must be registered to vote in Colorado and live in or own property in the District. A copy of this article is attached to the minutes.

**Motion:** It was moved by David Levy and seconded by Christopher Parker to accept the operations report for June 2023. There were no responses to the request for discussion. The Motion was voted upon and carried unanimously.

## **PRESIDENT'S REPORT**

Dave Levy brought up the TFPD Open House in August. Chief Norris stated there are flyers in the G-Drive and will post this in the paper 2 weeks ahead of the event. Porta Poddies will be rented for ease of use for the attendees. Discussion was held about needing someone to check people in and help with donations and TFPD merchandise. Judy Schmidt will be asked if she can help with this role.

Dave discussed the stipend report. It was mentioned that 25 shifts have been lost with the Smith family moving out of the District. Chief Norris covered 4 shifts.

**Motion:** It was moved by David Levy and seconded by Christopher Parker to approve the stipend pay for Chief Norris for June 2023. There were no responses to the request for discussion. The Motion was voted upon and carried unanimously.

### **OLD BUSINESS**

The Cook property land purchase, for a possible future location of a TFPD station, was presented again from a past agenda item. It was agreed upon that this topic will be pended again for a future date until after the engine that needs to be repaired is taken care of.

### **NEW BUSINESS**

David Levy presented an idea of purchasing a UTV with a pump and hose to aid the firefighters in extinguishing fires in remote terrain. Chief Norris stated that both Guffey and 4-Mile Districts have these UTV's. He stated that the District used to have ATV's but got rid of them in the past due to safety issues. He stated UTV's were safer. He mentioned that though UTV's can help in some cases, they aren't always practical. They only hold 50 gallons of water versus the trucks that can hold 300, 500, or 1000 gallons of water. He stated it is a "want" not a "need" and knowing that the #1 incident volunteers are called out for is motor vehicle accidents rather than fires, he felt it was not necessary at this time to further discuss purchasing UTV's.

Christopher Parker stated that David Levy was nominated for Board Member of the Year through the Colorado Special District Association. He read the nomination letter out loud at the meeting. Several points were made all showing how Dave has led the District through several challenges with outstanding management and leadership skills as well as with eloquence and grace. The letter is attached for the public to read. Way to go Dave. We all appreciate you!
