CALL TO ORDER AND ROLL CALL – Quorum established (at least 3 Directors Present)

No members of the public had any input for the meeting.

SECRETARY'S REPORT

Motion: It was moved by David Levy and seconded by Kristen Sanders to approve the Regular Board Meeting Minutes of April 10, 2023. There were no responses to the request for discussion. The Motion was voted upon and carried unanimously.

TREASURER'S REPORT

Chris pointed out certain items on the lead sheet to the Treasurer's Report:

The District decreased its cash position before reserves this month to \$139,794. The QB checking account cash balance, before reserves, as of March 31, 2023, was \$178,016.
 Address changed with IRS to the PO Box.

David Levy asked about the policy and procedures manual charge on the financial statements. Chief Norris explained it was a charge for the manuals and the updates per year to keep the district in line with the current state laws, best practices, and SOG's, & SOP's.

Chris mentioned the district was expecting to receive \$17k in May for tax revenue and \$47-\$50k more in June. Chris also stated he is keeping a separate detailed log for revenue categories to delineate where revenue is coming in from for future audits to make it easier to show.

Motion: It was moved by David Levy and seconded by Judith Schmidt to approve the Treasurer's Report for April's Financial Statements, 2023. There were no responses to the request for discussion. The Motion was voted upon and carried unanimously.

PRESIDENT'S REPORT

<u>Motion</u>: A motion was made by David Levy and seconded by Tamara Becht to approve and pay for the stiped amount to Chief Mark Norris. The Motion was voted upon and carried unanimously.

David Levy mentioned that there have been and will be many more trainings & public events coming up with the district and he encouraged the board members to volunteer as much as they are able.
