**PUBLIC INPUT:**

No members of the public offered commentary regarding the budgets.

**SECRETARY'S REPORT:**

**Motion:** It was moved by David Levy and seconded by Kristen Sanders to approve the Regular Board Meeting Minutes of November 11, 2023 and the Special Study Session Meeting Minutes of December 6, 2023. There were no responses to the request for discussion. The Motion was voted upon and carried unanimously.

Tammy Becht mentioned that she has been having issues getting into the TFPD website to upload documents in a timely manner. She has reached out to IT numerous times for assistance and has not been helped for up to a week later many times. Dave Levy contacted the manager of IT and he has been instrumental in getting the problem fixed.

**ADMINISTRATIVE MATTERS:**

**Motion:** It was moved by David Levy and seconded by Tamara Becht to accept Resolutions 2023-10, 2023-11, 2023-12 to add Leigh Bohannon to the Wells Fargo, Bank of San Juan and Chase Bank accounts as treasurer. The Motion was voted upon and carried unanimously.

**Motion:** It was moved by David Levy and seconded by Tamara Becht to accept Resolution 2023-13 adopting the 4<sup>th</sup> amendment of the 2023 District budget. There were no responses to the request for discussion. The Motion was voted upon and carried unanimously.

**Motion:** It was moved by David Levy and seconded by Judith Schmidt to accept Resolution 2023-14 to adopt the 2024 FY District Budget. There were no responses to the request for discussion. The Motion was voted upon and carried unanimously.

**Motion:** It was moved by David Levy and seconded by Kristen Sanders to accept Resolution 2023-15 to adopt the Appropriation of Funds. The Motion was voted upon and carried unanimously.

Resolution 2023-16 to adopt the Mill Levy is pending until new data is received by the County Assessors office. This will be discussed at the next meeting. The new extended deadline to file this document is January 10, 2024.

## **TREASURER'S REPORT:**

Leigh Bohannon began her report by discussing the points on the Treasurer's Report:

1. The District increased its cash position before reserves this month to \$260,411.10. The QB checking account cash balance, before reserves, as of Nov 30, 2023, was \$210,347.92.
2. Mill levy – The district is awaiting the updated Mill Levy
3. Approaching \$750k limit before audit- Currently: Revenue \$ 763,156.15 \$ Expenses \$ 687,320.61 \$ 62,679.39 remaining

It was mentioned that an audit will occur in 2024 as the District surpasses the \$750k limit. The audit could cost as much as \$12k.

**Motion:** It was moved by David Levy and seconded by Kristen Sanders to approve the Treasurer's Report for November 2023. The Motion was voted upon and carried unanimously.

## **OPERATIONS REPORT:**

Chief Mark Norris discussed the highlights of the November Operations Report:

- Incidents: - 6 Incidents in November, 100 total incidents for 2023 (136 - 2022, 147 - 2021, 146 - 2020) - See accompanying response reports.
- Membership: - 11(+1) Active Responders, 3(-2) Probationary, 0() Recruit, 6(-4) Engine, 5(-1) Overhead, 2(-2) Auxiliary Members
- Updates & Project Status: - E361 is being scheduled for repair as soon as we get the info and the engine deployment income is finalized. All repairs are being pushed out to next year.
- Stop the Bleed for the community is being scheduled based on instructor availability.
- Water tanks at the Canyon Springs station are mostly buried. Weather and Fire Restrictions stopped progress. Final connections need to be installed and burial completed. Brian and Karl were leading this project so there will be continuing delays until we get up to speed.
- TFPD attended the Cañon City Parade of Lights on December 2nd.
- No upcoming HOA meetings

Chief Norris mentioned they will be working with Deer Mountain for mutual aid with their ambulance service using our EMT's to assist. This will allow the EMT's to gain more experience as well. In the future TFPD plans to combine training events and get the teams together.

The next big training event will be held in March 2024 and will be thorough training on propane. Other surrounding departments will attend this as well.

## **PRESIDENTS REPORT:**

Dave Levy began by addressing his end-of-the-year observations and accomplishments.

He stated that the District increased the budget impressively over the last year. By doing this it has allowed the District to obtain more lifesaving equipment, extraction equipment, chain saws, PPE's, new radios (which leads to more reliable communication), more money for repairs and updates, and increased EMT training and supplies. The increased budget has also allowed for the volunteers to stay in a hotel during training in Colorado Springs rather than driving back each day. These are just some of the benefits seen over the course of 2023.

Dave also mentioned that the interpersonal relations among the board have been wonderful. There is good communication among the members, and everyone works well together as a team. This is certainly an improvement from years past and makes for more efficient operations and easier decision making.

## **OLD BUSINESS:**

Donations: A total of \$1210 was received in the month of November.

**NEW BUSINESS:** Kristen Sanders brought up the idea of making a blessing basket for the volunteers for Christmas. The board agreed and Kristen headed up the project and delivered them the next day. Thank you Kristen for offering to do this and thank you to the Chief and all the volunteers for all you do for the District! Merry Christmas everyone!

The next regular TFPD Board Meeting is scheduled for Monday, January 8, 2023, at 2:00 p.m. at the Main Station.
