<u>Motion</u>: It was moved by David Levy and seconded by Kristen Sanders to limit the number of shift coverages the TFPD Fire Chief can be paid for from August 1, 2022 through December 31, 2022 to twelve (12). There were no responses to the request for discussion. The Motion was voted upon and carried unanimously.

<u>Motion</u>: It was moved by David Levy and seconded by Kristen Sanders to request the TFPD Fire Chief to provide an informal accounting of his weekly hours worked and to include this information in the monthly Operations Report. This request is being made only to have his weekly hours in writing for future reference. There were no responses to the request for discussion. The Motion was voted upon and carried unanimously.
